## EXTENDED USES OF THE KNOWLEDGE OF HOMOEOPATHY SYSTEM OF MEDICINE

What is normal health? In other words, how will a healthy person behave mentally and physically? This can be ascertained by observing persons after they have been cured with correct homoeopathic medicines. This is because Homoeopathy does not aim at the cure of any 'diseases' but all that it does is simply to restore the sick of health. After a person is cured completely with the homoeopathic medicines no trace of disease remains and therefore, the result is perfect health mentally, physically, emotionally and morally too. Thus, Homoeopathic system helps us to ascertain what is normal health. Be that as it may.

By extending this analogy, we are able to discover many truths about the human mind and thus ascertain whether a particular mental faculty is normal or abnormal.

**CASE 1 :** A lady was telling her friends that she could foretell events in her family, such as even at 7 a.m. she will be able to say (prophecy) that her husband had met with an accident at 8 A.M. on that day and got admitted at 8-20 a.m. When the family members go and see they will find that person in the hospital in the same ward as predicted by her. At this time I intervened to ask whether she was having urinary trouble to which she replied in the affirmative and told me that she was waiting there

for a homoeopathic doctor to get medicine for that. Then I introduced myself as the homoeopath and explained her that when I give medicine, (Cannabis Indica), apart from curing her urinary trouble it may also remove that prophetic faculty in her, this was because, in homoeopathy we consider mental symptoms also and what she was having was an abnormality and not super-normality from the medical view-point. Immediately she told me not to give medicine for removing that faculty as her family members considered it as divine gift etc. I explained

remove that faculty but when a medicine is prescribed (Cannabis Indica which has the symptoms 'prophetic dream' etc. for her urinary trouble it may also remove that faculty. She, therefore, refused to take medicine from me but six months later when her urinary complaints became worse she had to take my medicine and after Cannabis Indica both her urinary difficulties as well as the prophetic ability disappeared.

**CASE 2 :** On another occasion it was a man of forty-two years who consulted me for peptic ulcer. (I already knew about this person; he could read the serial numbers of the currency notes in the pocket of anyone standing before him. Everybody admired him thinking that he was having E.S.P. Extra-sensory perception and so on.) I worked out his case on the symptoms presented by him in respect of his peptic ulcer and later it was learnt by me that while he was getting cured, the faculty of reading serial numbers of currency notes too diminished gradually. Though I did not consider this mental symptom for prescribing I could easily conclude that the remedy might be having the symptom in its pathogenesis

is in the other man's mind/pocket and become capable of predicting future. Then life would be without interest and everyone would be quarrelling with each other.

From the above two cases, as a true homoeopath, one is forced to conclude that E.S.P. etc. are not super-normal faculties but only abnormalities of mind WHICH IS A SIGN OF DISEASE and not normal health.

Therefore, a learned homoeopath cannot and will not admire anyone for possessing the ability to foretell events or bring from the air 'spatika lingam' 'prasadam's etc. a homoeopath would only conclude that the person would definitely be having some physical illness any if that is cured with correct homoeopathic prescription the mental faculty too will disappear.

There is no such thing as super health (be it of the body or the mind) and so E.S.P. and other qualities cannot be considered to be above normal but only abnormal. This is corroborated by the fact that homoeo remedies act on unhealthy tissues only, leaving healthy tissues untouched.
