He has divided the topics of this book into categories like modern methods of Drug proving, Sensitization, Allergy, Proving, Chronic Diseases, vividly discussed about bacteria, viruses, fungi and worms. He has further discussed about anxiety, degeneration of behaviour, different diseases and their homoeopathic therapeutics. Some of the diseases covered are ovarian cysts, palatal paralysis, splenomegaly, microscopic haematuria, renal calculus, arthritis, intestinal Koch's, fibroid uterus etc. and lastly compilation of groups as repertory. All these ailments, he has presented with illustrative cases, with investigations and follow up and has proved his point.
