

Predictive Homoeopathy & IIHP in North East

IIHP 2 Day Workshop In Guwahati, Assam, Oct 2005

A 2-day workshop was conducted by Dr S S Vithal and Dr S Tanvir Hussain at Hotel Orchid Guwahati organized by Progressive Homoeopathic Doctor's Association on 22nd and 23rd Oct 2005. The delegates were from all north eastern states and Bengal.

First session was started by Dr S S Vithal with some video records of the cases of the patient along with role of Homoeopathic medicines in acute and emergencies. He showed a beautiful video clipping from Dr Vijaykar's software on Acutes depicting MAN is made of PANCHMAHABHOOT ie Earth, water, space, air, fire.

THE FIRST CASE shown was of a boy suffering from Acute Lymphatic Leukemia which was cured on the basis of acute totality ie dullness, hot and thirst-less on dose of *Bry 200*. After 3 months the same child suffered from fever which was diagnosed as Pulmonary Tuberculosis. Now the medicine given was *Kali-sulph 200* on the basis of totality of symptoms. Within 2 months this child was reported as cured from tuberculosis also as shown in the pathological reports and X-Ray findings. He showed what the Homoeopathic medicines are, how they act in the human body, how suppression takes place in the body by wrong medication by showing Dr Vijaykar's Chart of suppression -this chart is nothing but scientific version of Hering's law of Cure.

SECOND interesting case was of an old man suffering from emphysema cured within 3 months by *Opium 200* only, proved by all lab investigation reports, X-ray findings and Scan reports.

CASE 3

Acute renal colic due to 12mm stone along with diabetes. Within 5 days, not only this stone removed but diabetes was also controlled. Everybody was astonished to see these cures with single dose of correct medicine on the basis of totality.

In the evening session Dr Tanvir discussed Miasms as told by Dr Vijaykar. He showed photographs of a child suffering from Neuroblastoma on left eye. It responded to a single dose of *Staph 200* based on totality. There was hot debate on this so called controversial topic. One of the delegates – a teacher from Homoeo College was not accepting this theory of defense mechanism of cell as miasm.

To further clarify this miasmatic theory Dr Vithal showed a case of bone Tb with diabetes. How this lady who was lying on death bed shifted from her syphilitic miasmatic disease to sycotic to psoric. There was interaction on almost all points. Most of the delegates participated in it. After the session, most delegates including students from different homoeo colleges had discussion with the visiting teachers and seemed satisfied with their experienced oration.

Day 2

Started at 9.30 AM with Dr Vithal on the dais. Topic: how to take case in Homoeopathic practice. He stressed, not only to write down what the patient says even in pt's language but also observe how he/she is speaking keeping your eyes on the body language of the patient. Here Dr Vithal acted like the pts of different constitutions. He cautioned not to prescribe on observations only but prescriptions should be made on qualitative totality. He showed a case of 15 years boy suffering from Chronic Asthma since childhood. After taking complete totality and repertorising; one dose of *Tuberculinum 1M* gave relief in physicals but suppressed it to third layer according to Dr Vijaykar's chart of ascending and descending of diseases ie

backache. Next medicine changed was *Iodium 200*. With this also pt's generals aggravated but physicals improved. Again after proper re-case taking the exact similimum medicine *Cinnaberis 200* was prescribed which did wonder. Not only mental generals and physical generals improved but cure took place according to Hering's law. In between the session so many delegates including teachers from homoeo institutions interacted.

After a brief break now the time was for Paediatrics and Homoeopathy. Dr S S Vithal narrated how the young children, whom most homoeopaths feel difficult, to treat, react to different situations like with the parents/guardians, without them, away from child etc. He tried to act like the different children, how they behave in clinics. Every body was so impressed with his presentation that throughout the whole session there

was pin drop silence in the hall. To further stress his points he showed different cases of children. In one case *Platina 200* not only brought back the voice of secondary deaf and dumb child but changed her personality from HE to SHE (original one).

After lunch Dr Tanvir took Group study of Homoeopathic Materia Medica. He showed general theme of diff groups ie Plants, Animal, Minerals, Nosodes, Sarcodes and Impondrabilia. Presentation on snakes was superb. Here he again stressed to go for the text books of our great stalwarts like Hahnemann, Kent, Farrington, Clark etc. There is no shortcut in homoeopathic practice. The patents, mixtures etc prevalent in the market are all against the fundamental principles of this great science. Never go for it, rather discard these.

The Match was not played due to Rains!!! What to Report??

I regret to state that I have not been able to attend the 16th International Homoeopathic Congress held at MURREE (Pakistan) due to apathy and reluctance by the Pakistan High Commission in New Delhi in granting Visa to Homoeopathic Doctors.

About 20 Doctors from Punjab and an equal number from Delhi and adjoining areas were stranded in New Delhi and other places for over a fortnight for Visa to participate in the above Seminar. They were finally told late in the evening on 21.9.2005 that Visa has not been granted when they were all set to catch the flight next morning from New Delhi to Lahore. Can you imagine
